MINUTES

Chairman James Mangan called the meeting to order at 9:04 a.m. with Commissioners George Miller and Corinne Johnson present. Also present were Supervisor Kevin Howard, Assistant Supervisor Dustin Howe, District Clerk Carol Richel and Administrative Assistant Tomi Maynard.

Approval of Agenda

George Miller MOVED to approve the agenda as presented. Corinne Johnson SECONDED the motion. James Mangan CONCURRED. The motion PASSED UNANIMOUSLY.

Conflicts of Interest on the Agenda

Chairman James Mangan asked if any Board member had a conflict of interest with any item on the agenda. Commissioners Corinne Johnson, James Mangan, and George Miller all indicated no conflicts.

Approval of Minutes

Miller MOVED to approve the minutes of the April 11, 2018 regular meeting. Johnson SECONDED the motion. Mangan CONCURRED. The motion PASSED UNANIMOUSLY.

Amy Manning and Lisa Fritz, III-A Insurance Update

Amy Manning presented a summary of the trust's annual report. Lisa Fritz discussed some new benefits being added to the health plan.

Cady's Corner Subdivision PILC Penalty Fee

Mr. Cady had entered into an agreement with the district, to obtain an extension of 3 years on the due date for the Payment In Lieu of Construction fee for his 4-lot subdivision. Cady was 60 days late with the final payment, which caused him to be charged interest based on the agreement. He paid \$198 of the interest, because he understands that it was his late payment that caused the interest accrual but is asking the board to reverse the remaining \$431 interest.

Miller MOVED to forgive the remaining balance, Johnson SECONDED, Mangan CONCURRED, the motion PASSED UNANIMOUSLY.

Russu Addition- Status Report

Mr. Robu attended to present to the board his request that the board vacate/abandon a right-of-way that cuts through the area he intends to build a residence on. The Board as well as Mr. Howard indicated that because of the location of the ROW to the current road, and the fact that the District has been maintaining the adjacent road without issue for some time, as well as the lack of impact on access to any other parcels, they are open to the possibility of vacation/abandonment, if the outcome of a public hearing on the matter doesn't turn up any valid reason the ROW should not be vacated/abandoned. Howard advised Robu that the property owners would be responsible to pay for any fees associated with that

vacation/abandonment, including but not limited to: The cost of legal notice printing, mailing notices to affected property owners as well as utility companies, any fees associated with special meetings that have to be held, engineering reviews, appraisals or surveys, and payment to the district for the value of the property being vacated/abandoned. Robu indicated that the vacation/abandonment is necessary for the building of the residence, so they would agree to paying the costs as necessary. Mangan directed Howard to send correspondence to the County indicating that vacation/abandonment proceedings are undecided but in process. Robu added that there is a smaller piece of property on the west side of the parcel that they will be dedicating back to the highway district. It was determined that if the decision is made to move forward, the value of the property being dedicated back to the district will be deducted from the amount owed by the property owners at the completion of vacation/abandonment.

Finnebott Bennion & Sun-Up intersections- Status Report

Howard reported that he will be meeting with the acquisition specialist tomorrow morning.

Koth/Kioth Road-Status Report

Howard stated that the weather has cleared and he anticipates the surveys being completed very soon.

Mangan reconfirmed that he would like lines to be marked by the district upon completion of the survey, in a fashion that cannot be easily tampered with. He also requested that the brush be removed from that ROW in a manner that makes it apparent that there is a ROW present.

Ritz Ranch- Status Report

Ritz Ranch is an intended 3 lot subdivision, located near Loff's Bay Road, proposed by Mark Ritzenthaler. No further updates at this time.

Revised Cash Flow

Carol presented the newly formulated Cash Flow document for the Capital Improvement Projects and Enhanced Maintenance. This change will allow the district to use the HB312 funds for crushing every other year.

NEW BUSINESS Staff Report by Supervisor Kevin Howard ON THE ROAD

The Cougar Gulch area is still posted for load limits (weight and speed restriction). However, every road in the WHD south of and including Dower and Presley Roads has been lifted.

The graveled roads were graded district wide. Gravel was spread on local roads where needed. Additional grading to blend in the spread gravel was done in preparation of the application of Magnesium-Chloride (mag).

The application of mag began Monday this week. As is standard operating procedure, they began in the South West corner of the district where the roads naturally recover from the winter weather first.

The crew swept and then washed with the flusher truck the paved roads to remove the remaining winter sanding material.

The district's two brush cutting tractors were used to clear brush from the ditch line. Additionally, the crew used chainsaws and the chipper to clean up behind the tractors and to cut the vegetation that was too large for the tractor. This process opens up site distance for the traveling public; providing safer travel.

No Parking signs were installed along Sun Up Bay Road and Four Echoes Road per the boards instruction last fall.

Where possible, ditches were cleaned. Although the soft road shoulders limited the crew, they managed to make notable progress in clearing the ditches.

A safety meeting that was followed by a CPR class filled a half of a day for the crew on April 12th.
