Sign request Carnie Road

James King is in attendance today to request placement of a no outlet sign and a neighborhood watch sign at the access to Carnie Road from US95. Neighborhood watch signs would be placed at the expense of residents, with District input on placement. A no outlet sign would fall under the District's jurisdiction and expense. Howard noted that in the past the district has only allowed no outlet or deadend sign placement when there were requests from multiple area residents. King indicated that he is representing a number of residents with this request. Johnson requested that King have those residents write or email their support for the no outlet sign request.

Miller MOVED to allow the placement of a neighborhood watch sign on Carnie Rd. Cooper SECONDED the motion. Johnson CONCURRED. Motion PASSED UANIMOUSLY.

3. Black Rock Flats PUD 19-0001U:

Attorney Susan Weeks is currently working on the Road Development Agreement (RDA). Susan intends on including the Order of Decision in the RDA and as such I have received a copy and forwarded it to her.

4. Tosi Estates, Minor Subdivision:

This is a two-lot subdivision at the intersection of Meadowbrook Loop and Clemetson Road. The district's review is complete. The response to Kootenai County Community Development was that the district's concerns have been met on the plat and the district has no objection to the plat application moving forward. No additional information this month.

5. Jaeger and King, Minor Subdivision, MIN19-0063:

This two-lot subdivision is proposed off of Northern Lights Boulevard which is served by Bunn Road. No additional information this month.

6. The Ridge at Sun Up Bay, 2nd Addition, MIN19-0069:

The aforementioned proposes converting a lot that is set aside for multiple drain fields to a residential lot. No additional information this month.

WHD Construction Projects

1. Rockford Bay Road/Loffs Bay Road (W) Intersection: Status Report

This project ranked in the ninth position for the STP - Rural Funding. The ranking is for Fiscal Years 2021 - 2027. Sponsors will be notified as funding comes available and by order of ranking.

2. Kidd Island Road Project: Status Report

This project is currently being advertised for construction by the Idaho Transportation Department (ITD). The Construction Engineering and Inspection (CE & I) scoring is complete and the chosen firm will be notified as soon as ITD has determined the outcome.

3. Watson Road Slide:

Conversations with the contractor, engineering and the district are starting up again to complete the project this spring. When scheduling and processes have been determined, staff will inform the board.

4. Hull Loop Project:

J-U-B will provide staking for one of the property owners so that they have a better idea as to the needed right-of-way for the project. No additional information this month.

5. Sun Up, Bennion, Finnebott Intersection Project:

Ranked #5 for funding. Staff will be watching the district's cash flow to determine if the district can move forward with the project or reluctantly not accept the funding. *

6. Watson Bridge Project:

Hydraulic evaluation is ongoing. The board can expect a summary within the next three months. No additional information this month.

*As a side note: with the given pandemic, fuel sales are down (at last report) 49% and will have a notable effect on the district's budget. This will have to be considered as the district moves forward with the desired projects.

WHD Misc. Projects

1. Koth Road ROW Status:

Attorney Weeks will be inquiring as to when this case will receive an arbitrator to complete the legal argument. No additional information this month.

2. Validation of road #20:

The hearing has been postponed until a later date due to the pandemic.

New Business

 Sign request for Carnie Road Addressed previously in the meeting.

2. Compensatory Time Policy

It has been the Districts policy that any compensatory (comp) time earned has to be used within 4 months, or it is automatically paid out to the employee. However, members of the crew had banked significant amounts of compensatory time, with the intention of using it for spring vacations. However, because of the pandemic much of those plans are not feasible at this time. Staff is requesting that under the unusual circumstances, the compensatory policy be temporarily changed to allow any time banked or earned to be used by the end of the fiscal year, alleviating the 4-month time constraint, but limiting the use of time to supervisor's approval.

Miller MOVED to extend compensatory use policy to end of fiscal year. Cooper SECONDED the motion, Johnson CONCURRED. The motion PASSED UNANIMOUSLY.
