OLD BUSINESS

Kootenai County Community Development

Bugle Ridge Estates MIN 24-0016, minor subdivision

This is a two-parcel subdivision off Bolen Street accesses Rockford Bay Road. The district's comments have been sent to Kootenai County Community Development. No additional information this month.

Farup Estates MIN 20-0099, minor subdivision:

It is now up to the applicant to circulate the Final Plate for signatures and request it be recorded. Kootenai County Community Development will check for recording by May 1st, 2025. No additional information this month

CDA National Reserve, Major Subdivision:

All of the roads have been paved. JUB has been monitoring progress, workmanship and ensuring that the roads meet district standards.

WHD Construction Projects

Rockford Box Culvert:

The easements necessary for construction have been defined. Legal descriptions are needed in order to move forward with the acquisition process. Kevin Howard spoke with Jay (JUB) about the descriptions and usability of them. JUB will be providing undated descriptions and acquisition will follow shortly.

Rockford Bay Road/Loffs Bay Road (W) Intersection:

The construction will be on hold this week and next as the contractor gives the utilities time to reinstall their facilities. Steady progress has been facilitated through emails and weekly on-site meetings.

Greensferry Guardrail, Key No. 23285:

The final design has been reviewed by Worley Highway District and the Local Highway Technical Assistance Council (LHTAC). The final design, with changes from the review, will be completed in the near future and is on schedule. No additional information this month.

Loffs Bay Road Participation Project (Cost Share Paving):

This project has been completed and will be removed from further staff reports.

Kidd Island Road (Phase II):

The right-of-way acquisition from Phase I has been completed. This was necessary for the district to move forward on phase II. LHTAC is in the process of figuring out what avenue they wish to take where engineering reviews and updates are required since the previous design is several years old.

Cougar Gulch Road:

This project is moving along rather quickly. The weekly on-site meetings have been useful for quick response to questions. Steady progress has been facilitated through emails and weekly on-site meetings.

WHD Misc. Projects

Koth Road ROW Status:

The most recent activity was during the last district meeting held on July 31st. You will find an overview of the activity in the meeting minutes of the July meeting.

CDA Tribe, Lake Creek Project:

Tribal Fisheries have been acquiring materials for the crossings slated for this year's installation. The district is prepared to begin the work when the Fisheries are ready.
