Staff is now requesting that the board rescind 2021-06. Johnson requested that the resolution be placed in the record.

- 1. The Club at Rock Creek, Major Subdivision, Loffs Bay Rd.:
 The Club at Rock Creek is preparing to request approval of the 3rd addition to the development. The board can expect to see this in the near future. Additionally, Staff is working on a resolution for the acceptance of the donation to the district. The donation is the completed final phase of the reconstruction of Loffs Bay Road adjacent to the subdivision.
- Axis Cove 1st Addition, MIN20-0103:
 Approved. It appears to have maintained the approval status after the appeal. The developer has **not** met all financial obligations to the district. As of 12-3-21, the Order of Decision from the county has not been rendered.
- 3. Ranch at Cougar Creek, MIN20-0057: Approved. Under appeal to hearing examiner at KCCD. As of 12-3-21, this is still in front of Kootenai County's Hearing Examiner.
- 4. Farup Estates, MIN20-0099:

This has been removed from Kootenai County's planning dashboard. Staff can only assume that since the signing was due in November, the subdivision application is now cancelled. Staff recommends removal of this item from the staff report.

- Rocky Point Reserve, MIN20-0088: This subdivision has been approved by KCCD on 7/15/2021. NEEDS FURTHER REVIEW.
- Farris Landing, MIN20-0089:
 This subdivision has been approved by KCCD on 7/15/2021. NEEDS FURTHER REVIEW.

1. Rockford Bay Road/Loffs Bay Road (W) Intersection: Status Report Field topography work has been completed. The boundary and base map preparation is in progress.

2. Kidd Island Road Project: Status Report

The Notice of Termination (NOT) is in process to be filed with the EPA as it pertains to the Construction General Permit. The agreement for stream monitoring is still in progress.

3. Watson Road Slide:

The physical portion of the project is complete. I met with Jay Baker, Idaho Office of Emergency Management field officer, for the final inspection. Due to the freshly fallen snow, a quick drive through the project was accomplished to give Mr. Baker perspective. The district will provide pre construction, construction, and post construction pictures for his use in closing out the project. A document was presented for my signature as witness that the project was completed per the design with any preapproved change orders. I signed the document on behalf of the district.

Johnson also signed a mediation agreement that had been previously approved by the Board.

4. Hull Loop Project:

The property owner in which the district made an offer has sought legal counsel.

5. Sun Up, Bennion, Finnebott Intersection Project:

A couple small items on the "Punch list" have yet to be completed. No additional information this month.

6. Solitaire Road:

The agreement has been signed and the financial assistance has been received from the community. This project is tentatively set for next summer. No additional information this month.

WHD Misc. Projects

1. Koth Road ROW Status:

The district's Attorney, Susan Weeks, would like to visit with the board in executive session when schedules allow. No additional information this month.

2. Validation of Road #20:

Geremy Russell, JUB, had the Record of Survey recorded at Kootenai County. Staff Recommends removal of this item from the staff report.

3. Rockford Bay Road, Speed Limit signs:

This project is complete. Staff Recommends removal of this item from the staff report.

Swede Bay Road Paving:

Telephone discussions regarding design and topographical limitation has happened. A drawing has yet to be produced for staff's review. No additional information this month.
