New Business

The Club at Rock Creek, Loffs Bay Road discussion

The Board has been asked to consider a proposal by the Club at Rock Creek (The Club), modifying the improvements. The Club will be making to Loffs Bay Road. After a site visit, and Howard's correspondence with engineers from both parties, it was determined that the improvements can be modified while still meeting the standards set by the American Association of State Highway and Transportation Officials (AASHTO) for a 35 mile per hour road. The Club has also proposed giving the District additional funds for the realignment of the intersection of Rockford Bay Road and Loffs Bay Road. These additional funds will allow the District to move forward on the realignment several years sooner than would be attainable otherwise.

Miller MOVED to accept a variance in the road design of Loffs Bay Road within 35 MPH speed design AASHTO Standards with the stipulation that the Club at Rock Creek assist with the funding for the intersection of Rockford and Loffs Bay Roads as proposed on February 8, 2020. Cooper SECONDED the motion. Johnson CONCURRED. The motion PASSED UNANIMOUSLY.

Kidd Island Road Project

Howard participated in a phone conference last week, to determine the status of this project. Currently, the only thing that prevents bid documents from being finalized and distributed is a pending review by LHTAC on behalf of the FHWA. This review is expected at any time.
