Kidd Creek Monitoring Agreement

Miller MOVED to sign the Memorandum of Agreement for the Kidd Creek monitoring. Miller SECONDED the motion. Johnson CONCURRED. The motion PASSED UNANIMOUSLY.

ON THE ROAD

Plowing, sanding and anti-icing was performed this month.

One of the district trucks (#190) was in a slow speed rollover accident. The driver had no apparent injuries but was sent in for a medical examination.

After receiving estimates on the truck repair, the truck was considered totaled by the district's insurance provider. Dustin and I confirmed that the truck value offered is accurate. Dustin negotiated the projected man hours to move the plow harness, sander body and controls to a replacement vehicle. Additionally, the salvage value was low so it was determined that it would economically provide many parts for the remaining fleet, therefore we retained the wrecked truck for salvage.

Load limits were posted on February 4th.

The crew rebuilt an approach to Watson Road that was removed during the slide repair. The replacement was part of the temporary construction easement agreement for the Slide Repair.

The crew cut brush on Belgrove Road and Cougar Gulch Road.

The crew worked on some building maintenance at the Mica and Sun Up Yards. At Mica, the old break room upstairs was cleaned, painted and shelves added. At Sun Up, the old restroom building that was part of the old rest area is being cleaned up and repairs made so that it can be used for storage.

- Truck #215 Rebuild the flusher body's water pump.
- Truck #235 Serviced.
- Tractor #585 repaired a hydraulic leak.

Planned work for this coming Month

- Winter maintenance. Plow snow, sand, de-ice, etc.
- Brush cutting along roadways that are being encroached by woody vegetation.
- When weather allows, sweeping winter sanding material from the paved roads.
