MINUTES

Finnebott Bennion & Sun-Up intersections- Status Report

Howard will be meeting with JUB this afternoon to obtain right-of-way maps, and info on the affected property owners at that time.

La Delcardo Bay Rights-of-Way- Status Report

Howard reported that the lawsuit that had placed this item on the agenda is not moving forward. The statute of limitations has passed for the claim to be filed against the district. In the event that it becomes necessary again, the District's attorney is prepared to defend the legality of the District's actions and is reasonably confident in the outcome. The board agreed to remove this item from the agenda.

Koth/Kioth Road-Status Report

Updates from Susan Weeks indicate that this issue is resolved. Mangan indicated that it is resolved from a legal standpoint, but on our end, there is still work to be completed. The Board wants the issue to remain on the agenda until the survey and marking of the original right of way is completed.

Staff Report by Supervisor Kevin Howard

ON THE ROAD

The crew performed typical winter maintenance throughout the month of January. Snow was plowed and sand applied when needed. Magnesium Chloride (mag) was applied to the paved collector roads prior to some of the weather events and on frosty days. The mag has been beneficial in reducing the snow floor buildup, reducing slick roads on frosty mornings and helping the retention of sanding

materials (a huge reduction in sanding material blowing off of the road by the traffic). There were periods when it was required of the crew to work overtime to complete the tasks.

Between weather fronts, the crew repaired surface damage to the roadways due to water (i.e. small washes, potholes, etc.). Additionally, crews cleaned debris from windfall trees and cleared brush from the roadsides.

When time and weather allowed, some ditches were cleaned with the tractor mounted ditching head and culverts cleared.

Hull Loop developed a soft spot that required excavation and build up with geotextiles and crushed rock. Mangan inquired the length of the soft spot. Howe reported a 100-foot length and 18 to 24 inches of depth.

The purchases of a new pickup and a used truck for the paint striper were made.
