# **Kootenai County Community Development**

Matteucci Estates (Loffs Bay Rd / Graysons Way) MIN25-0009, 2-lot minor subdivision: This application has been withdrawn and a subsequent application, FAM25-0011, in its place. Staff has responded to the new application with a "no objection" comment. This division of land in both forms will be removed from my report.

#### Clemetson Woods (Clemetson Rd) MIN22-0056, 3-lot minor subdivision:

The district's review and comments have been noted to Kootenai County. The district's comments have been addressed except for payment of the "Payment in Lieu of Construction" (PILC) fees. This fee is due prior to the signing of the Final Plat. No additional information this month.

# Belisle Landing (Hwy 95, Horned Owl Rd.) MIN24-0032, 2-lot minor subdivision:

Mylars have been presented for signature, all required fees have been paid.

Miller moved to sign the mylars for Belisle Landing. Johnson seconded. Cooper concurred.

The motion passed unanimously.

# Repsold-Hyatt (Rockford Bay Rd) MIN21-0115, 2-lot minor subdivision:

The district's review is complete. The signature of the final plat (Mylar) is pending payment of the PILC's. No additional information this month.

# Rockford Bay Ranch Second Addition (Hamaker Rd) MIN24-0037 4-lot minor subdivision:

Two parcels of the original Rockford Bay Ranch subdivision are being reconfigured and further divided into 4 lots. The district received the Payment in Lieu of Construction (PILC) fees.

# Summit Ridge (Cielo View) MSP24-0002 40 lot major subdivision:

The proposed subdivision is in Post Falls Highway District; however, it will be accessed by Espinazo Dr. and Cielo View Ct. The district received the \$2500 review fee deposit, and the Traffic Impact Study was sent to JUB for review.

# Lammon-Kelly Cove (Four Echoes) MIN25-0016, 2-lot minor subdivision:

This is a two-lot division of land that will produce a boat access only – non-residential lot. The intent is to build a small storage building for recreational items. The applicant is here today to request a waiver of the Payment in Lieu of Construction Fees.

Johnson moved to waive the Payment in Lieu of Construction fees for Lammon-Kelly Cove. Miller seconded. Cooper concurred. The motion passed unanimously.

#### WHD Construction Projects

#### Conkling Rd / US-95 Street Lights:

Design is ongoing. ITD's internal request for funding is on the July agenda for the ITD board meeting.

#### **Rockford Box Culvert:**

The pre-construction meeting is set for August 12<sup>th</sup>. The work is scheduled to begin September 2, 2025.

#### Greensferry Guardrail, Key No. 23285:

The pre-construction meeting is scheduled for August 11<sup>th</sup>. Work is scheduled to begin mid-August.

#### Kidd Island Road (Phase II):

Survey field work and base map developed (updating utilities); coordination with Utility companies has begun and mapping requested; STRATA has submitted draft Roadway Materials Report (RMR) for internal review; Environmental field work is complete - Aquatic Resources Delineation Report and environmental Categorical Exclusion (CE) are in development; working on Intermediate Design

#### Cougar Gulch Road:

Ruen, Yeager & Associates and WHD have been working with the contractor on the corrective measures needed to complete the project. It was agreed that the identified areas of concern for improper construction will receive exploration potholing for inspection of compaction and materials used. A schedule for the work to be performed is expected next week.

#### Conkling Park Dr.:

This project has been completed by a contractor. District crews have applied Mag-Chloride to make this portion consistent with the rest of the road.

The tentative starting date for the culvert placement for Lake Creek at Idaho Road is August 19th.
