# **DECLARATION OF SURPLUS EQUIPMENT**

WHEREAS Idaho Code §40-1309 provides that a public hearing shall be held and published in accordance with the provisions of Idaho Code §40-206, and at which hearing any person interested may appear and show cause that the equipment should not be sold.

WHEREAS the commissioners of the WORLEY HIGHWAY DISTRICT have elected to put the following equipment out for Sealed Bid auction.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Commissioners hereby declare the following equipment as surplus:

BE IT FURTHER RESOLVED that the equipment be sold by sealed bid auction with a minimum bid of Forty Thousand US Dollars (\$40,000.00). If the item is unsold after the sealed bid auction, it will be offered to the public at a live public auction with the same minimum bid. If the item is unsold after the live public auction, the Director may negotiate the sale of the Subject Property at a private sale to a member of the general public in a commercially reasonable manner for no less that the aforementioned minimum bid requirement and upon such terms and conditions as are in the best interest of Worley Highway District and otherwise deemed necessary and advisable. In which case, the Director or designated District staff is hereby authorized and directed to execute such necessary contracts, and other documents required to consummate the sale without further action of the Board of Commissioners (Board). Otherwise, the Subject Property may be sold at a price less than the minimum bid stated and upon such terms and conditions as are in the best interest of Worley Highway District and otherwise deemed necessary and advisable, with Board approval, following negotiations by the Director as directed by the Board, and upon such approval by the Board, the Director or designated District staff shall be authorized and directed to execute such necessary contracts and other documents required to consummate the sale without further action of the Commission.
