5. Misty Vale, MIN21-0098:

This subdivision is proposed off Vogel Road. The district's review has been given to Kootenai County Community Development. No additional information this month.

6. Spud Hill, MIN22-0032:

The district's concerns have been met as well as the obligations to the district. When the final plat is presented for signature, I'll conduct one last review of the Mylar and will have a recommendation for the board.

7. Harwood Estates, MIN

This subdivision is proposed adjacent to Meadowbrook Loop. I have reviewed the proposed subdivision and have no objection to the district signing the final plat pending one final review of the Mylar and receipt of the In Lieu of Construction Fees.

8. Serenity View Estates, MIN

This proposed subdivision is on Fox Haven Road (private) and served by Valhalla Road (public). The district has completed its review of the application and sent its recommendations to Kootenai County.

WHD Construction Projects

1. Rockford Bay Road/Loffs Bay Road (W) Intersection: Status Report
The district's right of way acquisition specialist has contacted two of the three property owners regarding acquisition.

2. Hull Loop Project:

The property owner in which the district made an offer has sought legal counsel. No additional information this month

3. Mica Creek Bridge:

Except for asphalt paving on the bridge deck, the project is substantially complete and open to the public with a gravel travel surface.

4. Greensferry Road & Cougar Gulch:

Boundary map verification is complete. Preliminary design setup is done and 30% design will start this month. No additional information this month.

5. Greensferry Guardrail:

Negotiations for JUB's service are complete. JUB will now begin working toward final design, right-of-way needs and bid documents.

Comstock added that LHTAC has requested some additional concept review to ensure the project provides the maximum safety impact while controlling costs.

9. Cougar Gulch:

I spoke with Laura- Ruen-Yeager & Associates yesterday. She plans to provide the receivables (Bid Documents) late this week or early next week.
