Approval of Agenda

All punch list items have been completed. Discussions continue on the warranty of a portion of the roadway that was impacted by a hydraulic spill during paving.

Kidd Island Road Project

All work that could be completed prior to winter has been buttoned up. Worley Highway District will perform winter maintenance. Knife River will resume work in the spring.

In 2008 when the Butcher's subdivided their property, adjacent to Kidd Island Road, a survey was completed establishing the ROW that the Butcher's were deeding to the District, and with that the Butcher's new property line. At that time there was a partially completed barbed-wire fence within the ROW that Butcher had signed over to the District. During the summer of 2020 Butcher began working to complete that fence. When District Supervisor Howard became aware that Butcher was building in the ROW, he asked him to stop work. Butcher feels that there were several miscommunications over the course of the past 12 years and has requested reimbursement for moving this fence out of the Highway District ROW along Kidd Island Road. He has presented an invoice to the District totaling \$1730.26. Johnson commented that the District has already agreed to cover the cost of a survey to locate the property pins that were previously established in 2008. She feels it would be reasonable to pay this invoice but does not believe that the District should be responsible in any way for rebuilding the fence on the existing property line.

Johnson MOVED to pay the invoice that Butcher presented. Miller SECONDED the motion. The motion PASSED.

Cooper re-entered at 8:19 AM.

IAHD Day at the Capitol

At the last meeting, the Board discussed who should attend this event. As all of the Commissioners are interested in attending, the Board directed Richel to take a look at District funds and determine how many people could attend. Richel reports that the budgeted transportation and meals/lodging balances would allow all of the commissioners and Howard to attend if their schedules and health allow it.
