# Approval of Agenda

Miller moved to approve the agenda as presented. Johnson seconded the motion. Cooper concurred. The motion passed unanimously.

#### **Koth Road**

Working on joint road validation with PFHD. Public Hearing tentatively set for January 22, 2025.

#### **Greensferry Guardrail**

JUB has received approval on design from Worley Highway District and ITD. They are working to complete the bid packet for advertising to get bids in winter of 2024-2025 for projected project start date of spring/summer of 2025.

The district and the contractor are discussing a material discrepancy, there are retainage funds being held until resolved.

# **Milhorn Abandonment**

# **Work Progress Report**

#### On The Road

The crew worked on the Rolling Hills Road Enhanced Maintenance project. This fall they placed ballast and base on approximately 3,000 feet of Rolling Hills Road. Additional gravel will need to be placed next year in order to complete the shaping of the surface.

The annual breakfast meeting was held on October 8<sup>th</sup>. The district board and crew recapped the work accomplished in the past fiscal year and discussed the plans for the coming fiscal year.

Gravel was spread on several roads that were thin on material.

The gravel roads were graded and set for winter.

The crew has been preparing the winter maintenance equipment for the upcoming season.

Work began on the fish passage, joint project with the Coeur d'Alene Tribal Fisheries on October 23<sup>rd</sup>.

The area between the Sun Up Shop and the Office was leveled, raked and grass planted on October 24<sup>th</sup>.

Hot mix patch was applied to Espinazo Drive after a "soft spot" repair had been made.

Dustin, Kurt, Spark and I interviewed a potential candidate to fill the mechanic's position at the district. After the interview, discussion followed. The following day Ted Taylor was offered the position, and he accepted the job. Ted gave his current employer his 2 weeks' notice and will be joining the district crew on November 6<sup>th</sup>, pending his separation agreement.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Commissioners hereby declare the following equipment as surplus:

**BE IT FURTHER RESOLVED** that the equipment be sold at a public auction. If the item is unsold after the public auction, the Director may negotiate the sale of the Subject Property at a private sale to a member of the general public in a commercially reasonable manner upon such terms and conditions as are in the best interest of Worley Highway District and otherwise deemed necessary and advisable. In which case, the Director or designated District staff is hereby authorized and directed to execute such necessary contracts, and other documents required to consummate the sale without further action of the Board of Commissioners (Board).

# WORLEY HIGHWAY DISTRICT RESOLUTION 2024-07

# A RESOLUTION OF THE WORLEY HIGHWAY DISTRICT BOARD OF COMMISSIONERS ADOPTING POLICY TO ADDRESS COUNTY ORDINACE 597, FAMILY DIVISION EXEMPTION

WHEREAS, the Board of Commissioners has the authority under Idaho Code, Title 40, Chapter 13, to carry out certain acts;

WHEREAS, The Board of Commissioners adopted Ordinance 2019-02 to maintain a safe flow of traffic, reduce congestion, reduce conflict points, improve travel times, preserve highway capacity and improve highway safety.

NOW THEREFORE, BE IT RESOLVED that the Board of Commissioners hereby adopts and implements the following policy for access to Family Division Exemptions:

- 1. Access shall comply with all the requirements of Worley Highway District Ordinance 2019-02 including access from a single common driveway. The ordinance includes a requirement that the subdivision must obtain an approach permit.
- 2. The applicant shall be required to dedicate right-of-way and easements in accordance with the Associated Highway District Standards. The Highway District will assist applicants in completing legal documents for the required dedications. Applicants shall provide the legal description of their parcel for use in the dedication documents.
- 3. Adjoining roadway improvements or contributions are not required.
- 4. The approach permit shall be conditioned upon final approval of the Family Free Split. If the Family Free Split is not granted, the access permit shall be void.
