MINUTES

Chairman James Mangan called the meeting to order at 9:09 a.m. with Commissioner Corinne Johnson present and Commissioner George Miller appearing telephonically. Also present were Supervisor Kevin Howard, Assistant Supervisor Dustin Howe, and Administrative Assistant Tomi Maynard.

Approval of Agenda

George Miller MOVED to approve the agenda as presented. Corinne Johnson SECONDED the motion. James Mangan CONCURRED. The motion PASSED UNANIMOUSLY.

Conflicts of Interest on the Agenda

Chairman James Mangan asked if any board member had a conflict of interest with any item on the agenda. Commissioners Corinne Johnson, James Mangan, and George Miller all indicated no conflicts.

Approval of Minutes

Miller MOVED to approve the minutes of the September 12, 2018 regular meeting. Johnson SECONDED the motion. Mangan CONCURRED. The motion PASSED UNANIMOUSLY.

Amended Budget Hearing

Chairman Mangan opened the hearing at 9:10 a.m.

Mangan stated that the largest changes to the budget were increases in revenue from the Highway User Fund and the State Sales Tax Fund. He attributed this to an upturn in economic growth and to Idaho's notably low 2.8% unemployment rate.

The proposed amended budget/Resolution 2018-10 for fiscal year 2017-2018 was presented as follows:

WORLEY HIGHWAY DISTRICT RESOLUTION 2018-10

WHEREAS, the Board of Commissioners of the Worley Highway District, Kootenai County, Idaho, shall

adopt RESOLUTION 2018-10 amending the fiscal year beginning October 1, 2017: Appropriating the sum of \$4,590,637.01, which sum includes less expenditures by the Worley Highway District in the sum of \$503,248.99; repealing all budgets and parts of budget in conflict and providing an effective date hereof.

Section 1

The Worley Highway District 2017- 2018 fiscal year budget, be and same hereby amended to read as follows:

The sum of \$4,590,637.01 be and the same is hereby budgeted to defray the necessary expenses and liabilities of the Worley Highway District, Worley, Kootenai County, Idaho for the fiscal year beginning October 1, 2017 and ending September 30, 2018.

Koth/Kioth Road-Status Report

Howard reported that surveying is set to take place on October 1 and 2.

Ritz Ranch- Status Report

Russu Addition -- Status Report

The district is still awaiting the final plat.

Brent Condie- Request to vacate/abandon additional section of Road 417

In the process of vacating right-of-way within the Russu addition, it was determined that there is right-of-way through Brent Condie's property. Brent Condie has made an informal request that the portions of Road 417 that runs through his property be vacated. He has not worked with staff to move that request forward at this time.

Commissioners Compensation

The following resolution was put into the record.

RESOLUTION 2018-09 COMPENSATION OF COMMISSIONERS

WHEREAS, Idaho Code 40-1314, Compensation of highway district commissioners, officers, agents and employees, requires the board of highway district commissioners of each highway district to fix the annual salaries of the commissioners commencing on October 1 and for the next ensuing year, and

WHEREAS, Idaho Code 40-1314, became effective July 1, 2002,

NOW THEREFORE BE IT RESOLVED, that beginning October 1, 2018 and for the 2017-18 fiscal year, the Worley Highway Board of Commissioners shall be compensated as follows: A salary of ninety dollars (\$90.00) shall be paid for each day, or part of a day, spent in the actual performance of duties.

Actual expenses shall be paid in addition to their compensation, upon the presentation of itemized vouchers, signed by the commissioners.

FURTHERMORE, WHEREAS Highway District Commissioners are considered employees of the District, as per Idaho Code 40-1314(4), and the District's Personnel Policy manual states that the district will provide health, vision and dental insurance for employees,

THEREFORE BE IT FURTHER RESOLVED that Worley Highway District will pay the premiums for medical, vision and dental insurance for the District Commissioners.

Mangan MOVED to approve Resolution 2018-09, setting the commissioners' compensation for fiscal year 2018-19. Maynard called the roll with the commissioners voting as follows: Commissioner Johnson, aye; Chairman Mangan, aye; Commissioner Miller, aye. The motion PASSED UNANIMOUSLY.

Authorize Pay raises

The 2018-19 fiscal year budget (as approved at the August 29 budget hearing) provided for a 4% wage increase for Step III crew members, and a 3% wage increase for all other staff.

Miller MOVED to approve the proposed wage rates for fiscal year 2018-19, as shown on the wage worksheet. Johnson SECONDED the motion. Mangan CONCURRED. The motion PASSED UNANIMOUSLY.

WORK PROGRESS REPORT by Supervisor Howard

ON THE ROAD

The bulk of the crew's time was spent on the Dower Road enhanced maintenance project. This week the project should be buttoned up for winter with the gravel surface complete and set.

The painted pavement markings have been completed. The only exception is that the crew will be putting a pavement overlay on a portion of Sun Up and Loffs Bay Roads which will be striped if the weather permits.

The crew got a healthy start on the Hull Loop enhanced maintenance project this past week and a half. The crew will move back to Hull Loop next week.

On September 19th the crew and staff participated in a Wellness Check and flu shot opportunity at the district office.
