7. Mica View Estates, Replat of Lots 1 & 2:

The district is waiting for the final plat (Mylar) to come before the board for signature. No additional information this month.

8. Lake Vista Estates:

This subdivision is just east of the end of Bennion Road. There is a public right-of-way through or adjacent to the proposed subdivision. I have requested that the right-of-way be shown on the plat. I have checked with Kootenai County and the status states "Pending Surveyor Review" as of September 7, 2018.

Howard noted that in addition to the subdivisions listed, there was an application received after his report was prepared, called Timber Shores. This proposed 2 lot subdivision is adjacent to Woodland shores in the Rockford Bay area. This application is in the review process.

WHD Construction Projects

1. Rockford Bay Road/Loffs Bay Road (W) Intersection: Status Report

Susan Weeks has placed the right-of-way acquisition for this intersection next on her list of tasks for the district following the Kidd Island Road acquisitions. No additional information this month.

2. Kidd Island Road Project: Status Report

In your packets you will find an update from Bionomics as to the studies, findings and data that have yet to be compiled. No additional information this month.

3. Finnebott, Bennion & Sun Up Intersections:

Right-of-way acquisition conversations are coming along well. The adjacent owners are busy with harvest right now so communications have been short and then only when the opportunity arises.

4. Watson Road Slide:

Some adjustments to the drainage are in process. The final design will be determined after further discussion with adjacent property owners. Further info will be discussed in executive session as it covers ROW acquisition.

WHD Misc. Projects

1. 2018 LHSIP Grant – Delineators & Signage:

The package (state wide) will go to the ITD board this month. If/when approved, an advertisement for bid will go out for the production of the materials. The bid will be awarded the

end of October. The materials will come to the district within 30 days of award. The district will then have 180 to install the signs.

Kevin further commented that this project will be coming in later than originally anticipated. His understanding is that LHTAC will extend our installation deadline if winter conditions keep staff from being able to install signs within the 180 day timeframe

2. Koth Road ROW Status:

Staff recommends discussion in executive session with the district's attorney present. No additional information this month.

3. Hull Loop:

This enhanced maintenance project will begin this week.

4. Dower Road:

This enhanced maintenance project should be wrapping up for the winter early next week.

New Business

Request to transfer funds from PILC to Special Construction

Clerk Carol Richel entered at 10:15 AM. She requested to move \$68,343.84 from the PILC fund, to the Special Construction fund, to reimburse for work that has already been done on Dower Rd.

Mangan MOVED to approve the request to transfer funds from the PILC fund to the Special Construction fund. Johnson SECONDED. The motion PASSED UNANIMOUSLY.

Request for District Credit Card for Admin Assistant

Richel requested permission to get another District credit card for Administrative Assistant Tomi Maynard. Because she lives in Coeur d'Alene it would be more convenient and less expensive to have her pick up supplies rather than Richel or Deputy Clerk Susan Kuykendall going to town to get them.

Mangan MOVED that the request be approved to authorize a credit card for the Administrative Assistant. Johnson SECONDED. The motion PASSED UNANIMOUSLY.

COMMISSIONER COMMENTS

Mangan discussed current traffic forecasts facing some of the most heavily travelled parts of Kootenai County.
