APPROVAL OF AGENDA

Miller MOVED to approve the agenda as presented. Cooper SECONDED the motion. Johnson CONCURRED. The motion PASSED UNANIMOUSLY.

PUBLIC COMMENTS AND GUEST INTRODUCTIONS

Encroachment permit, Shriner Road

Dan Baker is in attendance to request a permit to improve a section of Shriner Road. He provided an image of the area in question and described improvement plans in detail. Howard has no objection to allowing the improvement, conditional upon fire district approval. He indicated that this has been done on previous occasions.

Miller MOVED to approve an encroachment permit to allow improvements to Shriner Road. Cooper SECONDED the motion. Johnson CONCURRED. The motion PASSED UNANIMOUSLY.

OLD BUSINESS

Kootenai County Community Development

Unless desired by the board, projects that have seen no activity will not be read in the consideration of time.

- 1. CDA National Reserve, Major Subdivision, Loffs Bay Rd.:
 Phase 3 asphalt repair is in progress. Improper compaction around the buried utilities has caused need for removal of the asphalt, the addition of base material and proper compaction. Phase 4 has seen no road construction activity in need of inspection. The work being accomplished is total site grading (the shaping of building lots and landscaping).

3. Rocky Point Reserve, MIN20-0088:

I recently inspected the road improvements that had been accomplished within the public right-of-way. The work does not meet district standards as a public roadway but, however, will serve well as access to the few homes that it serves. 4. Ferris Landing, MIN20-0089:

I recently inspected the road improvements that had been accomplished within the public right-ofway. The work does not meet district standards as a public roadway but, however, will serve well as access to the few homes that it serves. 5. Misty Vale, MIN21-0098:

This subdivision is proposed off Vogel Road. The district's review has been given to Kootenai County Community Development. No additional information this month.

WHD Construction Projects

Rockford Bay Road/Loffs Bay Road (W) Intersection: Status Report
Test pits have been completed. The design will now be progressed to 50% for new Right-of-Way
needs.

2. Hull Loop Project:

The property owner in which the district made an offer has sought legal counsel No additional information this month.

3. Solitaire Road:

This project is complete.

4. Mica Creek Bridge:

Strata is working on preliminary geotechnical engineering for the sheet pile. The environmental permit applications have been started. Specification and bid package preparation will be kicked off this week.

5. Greensferry Road & Cougar Gulch:

The boundary map verification is underway and utility coordination and mapping has been received from all utility companies within the project limits.

6. Greensferry Guardrail:

LHTAC has sent a Request for Information (RFI) to a few engineering firms. They are looking for those interested in administrating the project as well as designing the project and performing the construction inspection.

7. Right-of-way Exchange, Kootenai County Solid Waste:

The ITD approach application to create a public intersection has been approved. Through Susan Weeks it has been confirmed that a public hearing will be required to exchange right-of-way with Kootenai County Solid Waste. JUB Engineers are preparing the legal descriptions of the parcels to be exchanged.

8. Cougar Gulch:

R&Y has reduced the previous design to STA 30+50 to 63+00, which is approximately from Miller Road to the Reed Family private drive, within the Idaho Department of Lands parcel. We do plan to provide 50-foot transitions to existing outside these limits.

R&Y has run the corridor with a 2:1 template and are currently analyzing the areas that catch beyond the right of way. We are exploring if there are areas we can adjust the profile, improve the mass haul balance, and bring the catch within the existing right of way. If this is not feasible, these will be the areas that have more of a 1.5:1 side slope and will require Allwest for engineered fill or rockery walls. We hope to get a meeting scheduled with Allwest very soon, to discuss the areas that will need their geotechnical services. We plan to have those areas staked in the field for convenience in identifying.

R&Y are redesigning the two approaches (Miller Road and the Reed private drive) to better accommodate current AHD approach standards while staying within the right-of-way acquired from the 2001 design. Primarily trying to correct the approach angle as much as possible within the row limits.
