Kootenai County Community Development

Clemetson Woods (Clemetson Rd) MIN22-0056, 3-lot minor subdivision:

The district's review and comments have been noted to Kootenai County. The district's comments have been addressed except for payment of the "Payment in Lieu of Construction" (PILC) fees. This fee is due prior to the signing of the Final Plat. No additional information this month.

Repsold-Hyatt (Rockford Bay Rd) MIN21-0115, 2-lot minor subdivision:

The district's review is complete. The signature of the final plat (Mylar) is pending payment of the PILC's. No additional information this month.

Rockford Bay Ranch Second Addition (Hamaker Rd) MIN24-0037 4-lot minor subdivision:

Two parcels of the original Rockford Bay Ranch subdivision are being reconfigured and further divided into 4 lots. The district received the Payment in Lieu of Construction (PILC) fees. No additional information this month.

Summit Ridge (Cielo View) MSP24-0002 40 lot major subdivision:

The district has responded to Kootenai County with a "no recommended additions or corrections to Cielo View Loop or Espinazo Drive." This item will be removed from the Staff Report until such time as staff finds a need to bring it back to the board.

Lammon-Kelly Cove (Four Echoes) MIN25-0016, 2-lot minor subdivision:

The request to waive the PILC fees was approved by the board. There will be no further action needed. This item will be removed from the Staff Report.

WHD Construction Projects

Conkling Rd / US-95 Street Lights:

Design is ongoing. ITD's internal request for funding has been approved. JUB will continue to work on behalf of the district to bring this project to the point of bid for construction

Rockford Box Culvert:

The pre-construction meeting was held on August 12th. The work is scheduled to begin September 2nd. The district has received several calls and emails concerning the road closure. Staff provided information regarding the alternate route to the Rockford Bay area.

Greensferry Guardrail, Key No. 23285:

The pre-construction meeting was held August 11th. Work is scheduled to begin September 2nd. There have been just a few calls from the public regarding the road closure. Pertinent information was shared with the callers.

Kidd Island Road (Phase II):

The Plans, specifications and Estimates (PS&E) is scheduled to be provided August 13, 2026. Scheduling to bid on the project will follow.

Cougar Gulch Road:

No schedule for the work to continue was provided by the contractor.

Bloomsburg Rd.- cost share project

A draft cost share agreement has been sent to the interested group for signature.

"Watch for Wildlife" Signs

A quote of \$879.10 for 12 signs was received by the district. This does not include sign post or labor cost to install. My request for a quote was to satisfy a curiosity as to the potential expense should this become a project. The question remains as to whether the added initial cost and future maintenance expense will be a realized benefit.

WORLEY HIGHWAY DISTRICT RESOLUTION 2025-04

COMPENSATION OF COMMISSIONERS

WHEREAS, Idaho Code 40-1314, <u>Compensation of highway district commissioners, officers, agents and employees, requires the board of highway district commissioners of each highway district to fix the annual salaries of the commissioners commencing on October 1 and for the next ensuing year, and</u>

WHEREAS, Idaho Code 40-1314, became effective July 1, 2002.

NOW THEREFORE BE IT RESOLVED, that beginning October 1, 2025 and for the 2025-26 fiscal year, the Worley Highway Board of Commissioners shall be compensated as follows: Compensation of eight hundred dollars (\$800.00) shall be paid for each commissioner each month.

All other expenses shall be paid in addition to their compensation, upon the presentation of itemized vouchers, signed by the commissioners on a quarterly basis. Vouchers must be turned in by the **15**th **day** of the month following the close of each quarter (Closing months December, March, June, & September). Statements turned in after this date will not be eligible for reimbursement.

FURTHERMORE, WHEREAS Highway District Commissioners are considered employees of the District, as per Idaho Code 40-1314(4), and the District's Personnel Policy manual states that the district will provide health, vision, and dental, and life insurance for employees.

THEREFORE, BE IT FURTHER RESOLVED that Worley Highway District will pay the premiums for medical, vision, dental, and life insurance for the District Commissioners.

RESOLUTION NO. 2025-03 Worley Highway District

ANNUAL APPROPRIATIONS RESOLUTION

A RESOLUTION OF THE COMMISSIONERS OF THE WORLEY HIGHWAY DISTRICT ADOPTING TO RECOVER FORGONE PROPERTY TAXES FOR THE FISCAL YEAR 2025-2026 BEGINNING OCTOBER 1, 2025 – SEPTEMBER 30, 2026.

WHEREAS, Idaho Code §40-801 empowers the commissioners of highway districts for the purpose of construction and maintenance of highways and bridges within their jurisdiction; and,

WHEREAS, Idaho Code §63-802 sets limitations on all taxing district budget requests on the amount of property tax revenues that can be used to fund programs and services; and,

WHEREAS, the Highway District intends to recover One Hundred Twenty-Two Thousand Five Hundred and Twenty-One and no/100 Dollars (\$122,521) for its current budget,

WHEREAS, the recovery forgone will be used to help fund a road project for Sun-Up Bay Road,

NOW, THEREFORE BE IT RESOLVED BY THE COMMISSIONERS OF WORLEY HIGHWAY DISTRICT, that \$122,521 of the current year's allowable increase to recover the forgone amount to be used in the Highway District's total.
